# **New Program Development Questions**

### Mission: Describe how the credential/degree aligns with the institutional mission or institutional strategic plan.

The degree addresses the structural and historical context of the life, history, and culture of Mexican-origin people in the United States. Indeed, this content is grounded in research that recognizes that the positive affirmation of a racial, ethnic, and/or cultural identity role ethnic studies courses provide function to increase the retention, persistence, and graduation rates of students of color. As such, the Master's degree will help to cultivate a new generation of educated public citizens empowered to improve the quality of life of Mexican American and Chicana/x communities in San Antonio, Texas, and across the nation. Focused on the exploration of Chicana/x experiences in their most broad, comprehensive sense, informed by several philosophical, epistemological, pedagogical and theoretical scholarship, the MA in Chicana/x Studies challenge students to link theory with practice, scholarship with teaching, and the academy with the community. The degree program is open to all who seek to challenge common sense notions, perceptions and enactments of race/gender/sexuality/economics/pedagogy/politics and consciousness itself. The degree's offering of specialized knowledge of underrepresented communities is useful in a variety of careers such as: # Teaching in community colleges, secondary schools, and K-12 levels # Researching in Ph.D. programs towards becoming university professors # Journalism, marketing, community and housing development, radio and television, health and medicine, community and union organizing, social

work The MA in Chicana/x Studies program will also build soft skills such as listening, writing, and presentation skills as well as critical thinking. Furthermore, the program will provide candidates who could fill the current 30 academic jobs listed on inside Higher Ed careers that call for a speciation on Chicana/x Studies. Our past MAS BA graduates have earned PhD's at Tier One and other public institutions across the U.S., such as University of Minnesota, University of Houston, Claremont Colleges, California State University, Fresno, and Texas Lutheran University. Furthermore, approximately fifty of our MAS graduates earned master's degrees in UTSA's Bicultural-Bilingual Studies Department. A degree in Chicana/x Studies would capitalize on undergraduate students' interest and enthusiasm towards higher education. According to data from Labor Insights (Burning Glass) between September 1, 2019 to August 30, 2020 there were 6592 job postings for MA in Ethnic Studies in the State of Texas.

Of the universities within a 200-mile radius, UT Austin offered an MA in Mexican American and Latino Studies, but terminated it in 2018 because they established a Doctoral degree in 2018. The University of Texas Rio Grande Valley offers an MA in Interdisciplinary Studies in Mexican American Studies (MAIS). The MAIS degree has an emphasis on border studies, while our proposal focuses on education. The UTRGV degree does not have data on recent graduates.

# Student demand: Provide evidence of both short-term and long-term student demand for the credential/degree.

The aim is recruit 10 students in the 1st year, drawing from our undergraduate population as well as professionals in the field such as secondary social studies teachers, K-20 teachers, and others seeking advanced knowledge of Chicana/x Studies working in the public sector. We anticipate approximately, 5 full and 5 part time to enroll. We then anticipate increasing enrollment by approximately 10 students per year. Adding 12 students in Year 3 and taking into account attrition and graduation, we expect to have 31 cumulative headcount by year 5.

# Existing Programs: Demonstrate the relationship between the proposed program and existing programs and any potential effects on enrollment for existing programs.

This would be the only Chicana/x Studies MA program in San Antonio to meet the growing interest in Chicana/x and Mexican American graduate research. Also, the program would be unique in its education focus and dedication to Texas-area educators in secondary schools and higher education. As more local-area schools and colleges implement Mexican American/Chicana/x Studies into their courses and catalogues, it will be mandatory that UTSA meet the growing need for graduate level courses.

This is a Master's of Arts degree program in Chicana/x Studies designed to develop advanced studies and interdisciplinary approaches, with a focus on education, to the study of Mexican origin people and communities in the U.S. and on the U.S.-Mexican borderlands. The MA program aims to provide scholarly preparation for students continuing onto a doctoral program and/or serving community needs in diverse professional capacities, including law, education, public health, and social services. Furthermore, the proposed program's focus on education will make it unique among current Chicana/o Studies MA programs nationwide. This is an interdisciplinary program of study focusing on cultural, historical, and sociocultural dynamics surrounding Chicana/o Studies and communities. Courses are designed for students who are interested in policy, research, and transcultural relations within various private and public institutions. Chicana/o curriculum complements a wide range of academic backgrounds including the humanities, social sciences, public policy, and business. The objectives of the program are to: 1. Create new knowledge about the diverse Chicana/x community 2. Acquire foundational knowledge in the field of Chicana/x Studies 3. Develop research skills in order to improve the material conditions of the Chicana/x community 4. Contribute to the ongoing cultural production within the community; and 5. Support social changes through a critical awareness and commitment to equity and social justice.

# Curriculum: Discuss or provide outline of the curriculum designed to build workforce-specific skills and knowledge, including new courses that will be needed. Describe what career-engaged learning experiences are incorporated in the curriculum to prepare students for the intended workforce.

Exiting courses include: MAS 5203. Chicanas/xs and Latinas/xs in the Media. (3-0) 3 Credit Hours. Close examination of the depictions of Chicanas/xs and Latinas/xs in US news and entertainment and film, problematizing mediated content as a site for the production and maintenance of culture, ideology, and political power. MAS 5213. Chicana/x Literature. (3-0) 3 Credit Hours. Introduction to the major writers of Chicana/o literature through the study of fiction, poetry, drama, and illustrated texts. Includes study of the cultural expressions within an historical and social context, cultivating critical principles that guide Chicana/o literature. MAS 5223. Pedagogies of Social Transformation in Chicana/x Education. (3-0) 3 Credit Hours. Exploration of the various pedagogical philosophies and practices that have shaped teaching/learning in Chicana/x social movements, community education spaces, and institutions of learning, from elementary school to higher education. Particular attention is given to decolonial, Chicana feminist, indigenous, liberatory, and anti-oppression pedagogies. MAS 6093. Chicana/Latina Feminist Methodologies. (3-0) 3 Credit Hours. This course examines the different frameworks for theory building by Chicana/Latina feminists. Challenging assumptions within social sciences, Chicana/Latina intellectuals have developed a critical theory that interrogates knowledge production. The course emphasizes methodology and how we produce knowledge, the means by which we examine communities, and how we conduct research as insiders/outsiders. (Same as BBL 6093. Credit cannot be earned for both MAS 6093 and BBL 6093.) MAS 6103. Interpretivist/Decolonial Histories in Chicana/x Studies. (3-0) 3 Credit Hours. This seminar is a critical examination of the historical experiences of Chicanas and Chicanos. The course is grounded in an analysis of the field of Chicana/o historical writing and within Chicana/o Studies from its inception to the present. (Formerly titled "Chicana/o Historical Thought." Same as BBL 6103. Credit cannot be earned for both MAS 6103 and BBL 6103.) MAS 6943. Internship in Mexican American Studies. (0-0) 3 Credit Hours. A supervised experience, relevant to the student's program of study within selected community organizations and agencies. May be repeated for a total of 6 semester credit hours. MAS 6953. Independent Study. (0-0) 3 Credit Hours. Independent reading, research, discussion,

and/or writing under the direction of a faculty member. For students needing specialized work not normally or not often available as part of the regular course offerings. May be repeated for credit but no more than 6 hours may count towards Master's Degree. MAS 6973. Special Topics in Mexican American Studies. (3-0) 3 Credit Hours. An organized course offering the opportunity for specialized study not normally or not often available as part of the regular course offerings. Special problems/topics courses may be repeated for credit when the topics vary, but no more than 6 hours, regardless of discipline, will apply toward the Master's degree. MAS 6943. Internship in Mexican American Studies. (0-0) 3 Credit Hours. A supervised experience, relevant to the student's program of study within selected community organizations and agencies. May be repeated for a total of 6 semester credit hours. Course Fees: GH01 \$90; INT! \$150; STSH \$30. MAS 6953. Independent Study. (0-0) 3 Credit Hours. Independent reading, research, discussion, and/or writing under the direction of a faculty member. For students needing specialized work not normally or not often available as part of the regular course offerings. May be repeated for credit but no more than 6 hours may count towards Master's Degree. Course Fees: GH01 \$90; STSH \$30. MAS 6973. Special Topics in Mexican American Studies. (3-0) 3 Credit Hours. An organized course offering the opportunity for specialized study not normally or not often available as part of the regular course offerings. Special problems/ topics courses may be repeated for credit when the topics vary, but no more than 6 hours, regardless of discipline, will apply toward the Master's degree. New Courses Needed: MAS 5243 Foundational Thought in Chicana/x Studies. Examines the creative, cultural, and intellectual production of Mexican American thought. Analyzes the historical context in which the field of Mexican American Studies emerged, as well as key constructs and theories that define the field, historically and contemporarily. MAS 5253 Chicana/ x Cultural Productions and Activism Explores Chicana/x/o visual art, music, literature, film, and social media to locate histories of cultural production as activism. Analyzes how Chicana/x/o cultural production reflects histories of political struggle, resistance, and empowerment, MAS 6013 Research Design and Methodology in Chicana/x Studies Explores a range of interdisciplinary research approaches pertaining to the investigation of the Chicana/x/o and Latina/x/o experience in the U.S. Analyzes the historical and contemporary intellectual trajectories that impact the methods and methodologies of the field. MAS 6123 Chicana/x Cultural Studies Interdisciplinary approaches to studying Chicana/x cultural production, with attention to the cultural frameworks and diverse methods of inquiry to studying cultural processes and practices. Topics of investigation will focus on identity, power, agency, and ideology, among other themes.

The Master's of Arts degree program in Chicana/x Studies is designed to develop advanced studies and interdisciplinary approaches to the study of Mexican origin people and communities in the U.S. and on the U.S.-Mexican borderlands. The MA program aims to provide scholarly preparation for students continuing onto a doctoral program and/or serving community needs in diverse professional capacities including law, education, public health, and social services.

Admission Requirements:

- 1. GPA of 3.0 or better from the last 60 credits of undergraduate coursework.

- 3. Two letters of recommendation from professors or individuals in the community who can address the applicants' strengths
- 4. Our department takes a holistic approach in reviewing applications. We acknowledge a breath of academic and community-based experiences that students bring to the program.
