I respectfully request the following items to be added to the Faculty Senate's May 2011 meeting agenda.

- The Department of Health and Kinesiology proposes to change from a Community and Public Health Specialization to a Community and Public Health concentration within the B.S. in Health degree. Justification: The School Health specialization has been removed; thus, the Community and Public Health track is the only one offered under the new catalog. Changing the specialization to a concentration would allow the Community and Public Health designation to be on the students' transcripts.
- 2. The Department of Health & Kinesiology proposes admission criteria for health majors [see attached]. Justification: The goal of the admission requirements for this degree is to provide undergraduate students with a program of study with the highest possible standards. To achieve this goal, the admission policy is designed to identify those students most likely to succeed in community health.
- 3. The Department of Health and Kinesiology proposes to change from an Athletic Medicine Specialization to an Athletic Medicine Concentration within the B.S. in Kinesiology degree. Justification: The Athletic Medicine track is very distinct from the other degree tracks offered. A concentration in Athletic Medicine will be included on the students' transcripts depicting this distinction.
- 4. The Department of Health and Kinesiology proposes to change from an Exercise Science and Wellness Specialization to an Exercise Science and Wellness Concentration within the B.S. in Kinesiology degree. Justification: The Exercise Science and Wellness track is very distinct from the other degree tracks offered. A concentration in Exercise Science and Wellness will be included on the students' transcripts depicting this distinction.

5. The Department of Health and Kinesiology proposes to change from a Physical Education Specialization to a Physical Education Concentration within the B.S. in Kinesiology degree. Justification: The Physical Education track is very distinct from the other degree tracks offered. A concentration in Physical Education will be included on the students' transcripts depicting this distinction.

## Bachelor of Science in Health Degree in Health Admission Policy

The goal of admission requirements for the Health degree is to provide its undergraduate students with a program of study with the highest possible standards. To achieve this goal, the admission policy is designed to identify those students most likely to succeed in health education. All applicants for admission to the Health degree will be admitted to the program as pre-health students. Academic performance for declaration of the Health major will be evaluated after the following criteria has been met. To declare a Health major, a pre-health student must have:

- · completed 30 semester credit hours and be in good standing with the University
- successfully completed the following or equivalent courses with a grade of "C" or better:

WRC 1013 Freshman Composition

WRC 1023 Freshman Composition II

HTH 2413 Introduction to Community and Public Health

Applicants who have completed all the above courses as equivalent transferable college credit with a grade of "C" or better and have no UTSA coursework can declare a health major if they:

- meet all UTSA undergraduate admission requirements
- · completed 30 semester credit hours

A Pre-health student will not be able to register for upper division majors only classes at UTSA until they have completed the courses listed above with the required grade point average. A student can complete each course required for admission twice in order to reach the required grade; however students who are not able to meet the criteria after completing the course twice will no longer be considered a pre-health student and their major will be changed from pre-health to undeclared (UND) in the University student record system. The student must choose a major other than Health.

**Rationale:** The Department of Health & Kinesiology proposes admission criteria for health majors. ### Bachelor of Science in Health Degree in Health Admission Policy

The goal of admission requirements for the Health degree is to provide its undergraduate students with a program of study with the highest possible standards. To achieve this goal, the admission policy is designed to identify those students most likely to succeed in health education. All applicants for admission to the Health degree will be admitted to the program as pre-health students. Academic performance for declaration of the Health major will be evaluated after the following criteria has been met. To declare a Health major, a pre-health student must have:

- completed 30 semester credit hours and be in good standing with the University
- successfully completed the following or equivalent courses with a grade of "C-" or better:

WRC 10 13 Freshman Composition

WRC 1023 Freshman Composition II

HTH 241 3 Introduction to Community and Public Health

Applicants who have completed all the above courses as equivalent transferable college credit with a grade of "C-" or better and have no UTSA coursework can declare a health major if they:

- meet all UTSA undergraduate admission requirements
- completed 30 semester credit hours

A pre-health student will not be able to register for upper division majors only classes at UTSA until they have completed the courses listed above with the required grade point average. A student can complete each course required for admission twice in order to reach the required grade; however students who are not able to meet the criteria after completing the course twice will no longer be considered a pre-health student and their major will be changed from pre-health to undeclared (LIND) in the University student record system. The student must choose a major other than Health.
