# SUMMARY MINUTES OF THE FACULTY SENATE MEETING of May 7, 2015

The regular monthly meeting of the Faculty Senate for the 2014-2015 academic year was held May 7, 2015, at 3:30 p.m. in the Assembly Room (JPL 4.04.22) with Dr. Karen Daas, Chair of the Faculty Senate, presiding.

### II. Consent Calendar

- 2015-2017 Graduate Catalog revisions The proposed revisions were scheduled to be approved electronically.
- Approval of the April 9, 2015 meeting minutes
- III. Reports

A. Chair of the Faculty Senate – Karen Daas Dr. Daas gave an update on EARN. She said that faculty and advisors have been discussing the functionality and will meet with the Provost within the next few weeks to discuss whether or not to move forward with the system. She said that HOP 2.20 Peer Observation of Teaching and HOP 2.38 Program Abandonment are in the approval stages with no substantive changes. Dr. Daas said that an external review of Business Affairs is being conducted to potentially improve some processes and procedures. She gave a quick legislative update and said that UTSA may receive a 5% budget increase (as opposed to a 5% decrease which was previously being discussed). About 2/3 of the funding needed for a new building on the main campus has also been projected. Unfortunately, there is likely to be a 7% increase in benefit premiums next year for employees. Dr. Daas said that the Chancellor has pledged to help universities with financial assistance for increased security if campus carry passes. Dr. Daas announced that the first fall senate meeting will be held on Thursday, September 10<sup>th</sup> and thanked senators with an expiring term for their service.

- B. Provost's Report John Frederick
  Dr. Frederick encouraged everyone to attend the faculty mixer immediately following the senate meeting.
- IV. Election of Standing Committee Members for 2015-2016 The senate voted to unanimously approve the slate of candidates for all standing committees and panels as presented by the Nominating, Elections, and Procedures committee.

- V. Reports, con't.
  - C. APR Committee Patricia McGee

The APR Committee reviewed a proposal for changes to the undergraduate transfer requirement. The goals of the proposal are to assist students in completing their application, and helping them meet the qualifications to transfer. The committee voted to approve the proposal with a few changes (see full report for details). **The senate voted to unanimously approve the proposal.** 

The second proposal on the freshman high school ranking strategy will be distributed for electronic vote to senators after further review by the APR Committee.

- D. Curriculum Committee Alistair Welchman
  Dr. Welchman said that his committee reviewed 3 proposals (see full report for more details):
  - 1. <u>Minor in Environmental Science</u> the committee recommends approval. **The senate voted to unanimously approve this proposal.**
  - 2. <u>BS in Chemical Engineering</u> the committee recommends approval. The senate voted as follows: 21 yes, 0 no, 3 abstentions. Therefore, the proposal was approved.

- <u>BA in Multicultural Early Childhood Education</u> the committee recommends approval.
  The senate voted as follows: 18 yes, 0 no, 6 abstentions. Therefore, the proposal was approved.

#### VII. New Business

- Two Factor Authentication
  - Anthony Espinoza, Information Security Officer
  - Mark McCoy, Identity Management Analyst

Mr. Espinoza explained that due to some security incidents regarding credentials being compromised within the UT System, two-factor authentication will now be required for off-campus access. This system is being implemented across the entire UT System. Currently, two-factor is only being implemented for faculty and staff.

Two identifying factors will now be used to identify a user: a user name/ passphrase and an object such as a cell phone. If a user does not have a smartphone or prefers not to use their phone/tablet/other smart device, a string of passcodes can be generated to be used at the time of login. However, each passcode is a one-time use. Additionally, once a device is selected (cell phone or tablet), that is the device that must be used going forward.

If the user's device gets lost/replaced/changed the pairing can be reset on the new device by contacting OIT or by sending the link to the user's email address on file. Additionally, if the user is somewhere without network connectivity, a one-time password can be generated on the device.

The start date for implementation of two-factor authentication is August 31, 2015 for the VPN, server administration, and PeopleSoft use. Later in the fall, the ASAP faculty services tab will also require two-factor authentication. A "how-to" guide is currently being developed and an email was recently sent out announcing upcoming information sessions.
