## The University of Texas at San Antonio Number of Course Exemption to the Six-Drop Policy

Effective Fall 2007, the six-drop policy limits each student to dropping no more than six courses throughout his/her undergraduate college career at Texas public institutions of higher education. Under section 51.907 of the Texas Education Code, "an institution of higher education may not permit a student to drop more than six courses, including any course a transfer student has dropped at another Texas public institution of higher education." There are exemptions that may allow a student to drop a course without having it count against the six-drop limit, but it is the student's responsibility to demonstrate good cause. Exemptions for good cause are listed in Number 4 below.
