**2009-2010 CONFIRMATION OF FINANCIAL RESOURCES**  
**For F-1 & J-1 visa students seeking a Master's or Doctorate Degree**

**This form is required for the preparation of Forms I-20/DS 2019 for students entering UTSA in the Fall 2009, Spring 2010, or Summer 2010 semester and is valid ONE YEAR from the date of your signature. Supporting documentation is valid ONE YEAR from its official date.**

*The United States Citizenship and Immigration Services (USCIS) mandates F-1 and J-1 student's must provide documentation of financial resources for at least one year of study **prior** to issuance of the I-20/DS 2019. Adequate funding should be valid and available from the same or equally dependable sources for subsequent years of study. The cost of tuition is determined by the legislature of the State of Texas and is subject to change without notice.*
