University Vice Provost & Dean, University College, Arizona State University (2004-present). \$25.7M budget; 65 faculty; 160 staff. University College is an academic unit located on all four ASU campuses with responsibilities for undergraduate exploratory students (~5,000); Bachelor of Interdisciplinary Studies majors (~2,300); students in continuing and professional studies programs (~25,000); and for student retention and success across ASU. University College is the primary liaison to Arizona community colleges for partnerships leading to the baccalaureate and houses staff working on academic articulation across postsecondary institutions in Arizona. University College also hosts degree programs, operates as a degree incubator, and offers all general education and non-major courses for students on the new ASU Downtown Phoenix campus, which opened in August 2006. On University Provost's Senior Leadership team working on various projects; participate in Arizona Board of Regents' Chief Academic Officers meetings.

- University College is the academic anchor for the new ASU Phoenix Downtown campus, functioning as a College of Arts & Sciences. The new campus is a collaboration between ASU and the City of Phoenix, concept to campus opening with 3,000 FTE students and 600 faculty in 18 months (34 faculty in UC downtown).
- Worked with architects and design firm on the design and renovation of academic facilities for the Downtown Phoenix campus.
- Established Student Success Center on Downtown Phoenix campus; one-stop shop for student academic support services (advising, tutoring and coaching, supplemental instruction, major and career advising, and support for transfer students co-located with admissions, financial aid, and registrar and disability resource services).
- Developed and have begun to implement plan for the School of Extended Education to greatly expand ASU distance education and online enrollments to 100,000.
- Created online and on-site major and career exploration programs for "exploratory" students.
