An original, signed letter dated within the Meal Plan Contract period from student's physician/specialist on his/her letterhead outlining i) the specific reasons why the UTSA Meal Plan does not meet student's dietary requirements and ii) specific changes to offerings that would meet student's dietary needs.							
		2. A specific nutritional plan provided by student's physician/specialist on his/her letterhead to include: i) a seven day menu outline, ii) special preparation instructions, and iii) where food will be prepared.							
Additional documentation may be requested to substantiate cancellation requests for medical reasons. Director of Campus Services reviews cancellation requests submitted for medical reasons. Campu provide a decision to the student after receiving all of the required documents, and if necessary, refrom a meeting with the UTSA Dining Dietitian.
