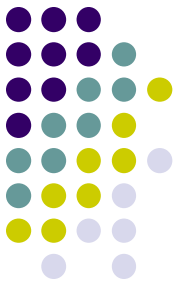


According to our bylaws (Article IV):

- All Faculty Senate meetings are open to the public
- Participation of individuals other than senators is limited to the Open Forum. The Faculty Senate can vote to allow an individual to participate.
- The Faculty Senate may vote to go into executive session, at which time only voting members of the Faculty Senate are present.

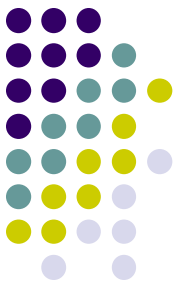

- Graduation rate
 - 6 year graduation rate is 26.3%
 - 44.5% of incoming freshmen class are upper quartile
- Enrollment management
 - Targeted cap at 30,000 students
 - Increasing graduate enrollment, decreasing undergraduate enrollment
 - 84% admission rate (compared to 99.4% in 2005)
- Legislative Appropriations Request
 - (\$21 Billion state shortfall)
 - Experimental Sciences Instructional Building (\$16M)
 - SALSI initiative (\$4M; last year was funded by ARRA)

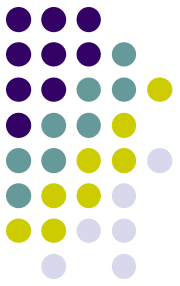

- Wayfinding project (exterior signs on campus)
 - Consultant fees for design: \$750K
 - Total cost for signs: \$4M, over several years
- PeopleSoft project (to replace Define)
 - One-time implementation cost: \$7M in the next 3 years (\$2.5M in 2011, \$3.5M in 2012, \$1M in 2013)
 - Ongoing operational cost: (net increase of \$1.1M per year)
 - \$1.5M per year
 - As opposed to \$400K for Define
- Negotiations with federal agencies to increase F&A rate:
 - Current rate: 44.5%; Target rate: 75.6%
