


Legislative News



- Budget cuts:
 - Initial senate and house appropriation bills are being analyzed.
 - One concern is the proposed cut of financial aid for students (Texas Grant Program).
- Rule on approval of doctoral degree programs
 - THECB has adopted a rule to only approve new doctoral degree programs if the institution's six-year baccalaureate graduation rate equals or exceeds the average statewide graduation rate

Senate Procedures




Meetings (Bylaws IV.5):




UT System Regents' Rule 40101, 2.2:

Subject to the authority of the Board of Regents and subject further to the authority that the Board has vested in the various administrative officers and subdivisions of the System, the faculties of the institutions regularly offering instruction shall have a major role in the governance of their respective institutions in the following areas:

- 3.1 General academic policies and welfare.
- 3.2 Student life and activities.
- 3.3 Requirements of admission and graduation.
- 3.4 Honors and scholastic performance.
- 3.5 Approval of candidates for degrees.
- 3.6 Faculty rules of procedure.

- Teaching evaluations resolution:
 - Approved with modifications:

instrument may provide individual faculty with important formative student feedback, the instrument is currently in a testing phase. Until the validity of its results is confirmed, any attempt to use data resulting from it for summative evaluation must be done with prudence. Therefore, pending comparison of the results with previous semesters' IDEA results, the data generated from the test phase instrument should not be considered as part of the annual performance review for 2010 cannot be valued at a level less than "good" (2.5) for purposes of annual merit evaluation. Evaluation of a faculty member's overall annual teaching effectiveness should in all other ways comply with his/her department's established evaluation guidelines
