SUMMARY MINUTES OF THE FACULTY SENATE MEETING of September 8, 2011

The regular monthly meeting of the Faculty Senate for the 2011-2012 academic year was held September 8, 2011, at 3:30 p.m. in the University Room (BB 2.06.04) with Dr. Carola Wenk, Chair of the Faculty Senate, presiding.

I. Call to order and taking of attendance

II. Approval of the May 5, 2011 minutes

The minutes were approved.

III. Reports

A. Chair of the Faculty Senate - Dr. Carola Wenk

Dr. Wenk briefly talked about the role of the Faculty Senate and other shared governance bodies. She discussed the faculty's role, according to the UT System Regents' Rule 40101. Dr. Wenk noted Misty Sailors as the new Faculty Senate representative on the Research Advisory Council (RAC) for the Vice President for

Research. She reported that a task force has worked on recommendations for "Super NTT" positions. Recommendations include a special title, a new recruiting mechanism involving search committees and an external search, as well as the online recruitment system STARS, and guidelines for annual evaluations. She also spoke about the new F&A distribution guidelines and the changes for this year. Also mentioned was the new 1,800 sq ft. faculty gathering area being constructed on the 4th floor of the JPL. This area will be for faculty (current and retired) to gather, and can be used as an outlet for learning and collaborating with other faculty members. Dr. Wenk said that volunteers are needed to work with Jesse Zapata on the Faculty Handbook. Dr. Wenk discussed some HOP policies, including 2.04 (dealing with faculty recruitment) and 10.02 (misconduct in research and other scholarly activities). HOP 2.04 has been updated according to Faculty Senate recommendations. HOP 10.02, although unanimously rejected twice by the Faculty Senate, is now posted with some minor revisions. The HOP amendment process was discussed, with the Faculty Senate Executive Committee proposing a revision which gives greater weight to the Faculty Senate. A note was made about giving input for the federal IRB regulations. The Department of Health and Human Services is revising regulations on protections for human subjects and they are asking for input via the web. She said that senators can access more information about this request on Rowdyspace. A brief update was given by Tom Coyle, who reported that the Committee on Course Surveys met with Steve Wilkerson to float a proposal to move course surveys up to the 13th week of fall courses, the week of November 14, in order to give students more time to focus on the surveys. There were no objections to this proposal among the committee's members, and it was suggested that giving the surveys earlier might allow students to focus more on instruction and not their final grade when completing the course evaluation. B. Secretary of the General Faculty - Dr. Amy Jasperson

Dr. Jasperson discussed the upcoming UT System Faculty Advisory Council meeting and gave a brief overview of the University Assembly's role. She discussed the Chancellor's Framework for Advancing Excellence that he presented to the U.T. Board of Regents on August 25 and the corresponding action plan containing nine focus areas. One important focal area is the goal of increasing blended learning opportunities for student success. The Regents want to create an Institute for Transformative Learning to support competitive funding for the most innovative online courses to apply across all campuses. A new resource (www.myedu.com) for students will be adopted that collects data from campuses to help students organize their academics. Further, she mentioned that the Chancellor wants to strengthen the annual evaluation process, the post-tenure review process, the review of all administrators and staff, and to conduct formal external reviews of schools and programs. Dr. Jasperson noted that there would

be more information to come on the Blackboard/ASAP integration at the University Assembly meeting on Tuesday.

IV. Election of Officers and Members of Standing Committees

Before voting on standing committee membership for 2011-2012, a motion was made, seconded, and unanimously passed to renew the Faculty Senate ad hoc committees, including the IRB Committee, Faculty Senate Research Advisory Committee, and the Committee on Course Surveys.

Additional nominations were taken from the senate floor for the officer positions and members of standing committees. Results of the Election can be found in Appendix A.

V. Reports

C. Provost's Report –Dr. John Frederick

Dr. Frederick discussed the merit exercises happening this fall, and said that the pool for merit increases is 2.25%, which will be used to provide raises for eligible faculty that will be added to the base salary. Faculty may select the better of the last two years of annual reviews for their merit evaluation. Dr. Frederick said that the merit increases will be effective as of the December paycheck. Dr. Frederick assured the faculty that there will be no layoffs in the university proper, even though both the ITC and the PREP experienced a cut in personnel. He mentioned that there are new reporting requirements which will provide more information on Faculty are asked to post as much accurate and relevant student success. information as possible on FAIR in keeping with the emphasis on transparency. This data will be used for new reporting requirements. In addition, the university will be offering voluntary separation packages for those who meet the "rule of 80" (age plus years of service). Qualifying faculty will receive information packets soon. Dr. Frederick reminded everyone that the university will host Strategic Implementation Planning sessions to obtain input from the university community. The first sessions are on September 9 at the Downtown and 1604 (main) campuses. He also mentioned that the new North Paseo Building is almost complete. Next summer, construction is scheduled to begin on a new office building. The building will allow off-campus offices to return to the campus. Dr. Frederick also touched on a new program, Freshman Focus, and said that it will revolutionize the way UTSA handles freshmen. This program is an outgrowth of the Freshman Academic Experience Task Force's report, which focuses on student success.

D. Academic Policy and Requirements Committee – Dr. George Norton (for Dr. Bennie Wilson)

Dr. Norton said the committee had two proposals to present to the Faculty Senate. He said both of the proposals had been approved for recommendation by the committee.

- 1. Changes to Undergraduate Admissions Criteria A motion to approve was called and unanimously approved.
- 2. Changes in Admissions Criteria for the College of Business A motion to approve was called and unanimously approved.
- E. Curriculum Committee –Dr. Raydel Tullous

Dr. Tullous had four proposals to present to the Faculty Senate.

1. Proposal for BS in Public Health

A motion to approve the proposal was called and the proposal was open for discussion. There was a motion to vote by paper ballots which was seconded, and approved. The results of the paper ballot vote were in favor of the policy, which passed by majority vote.

There was a discussion about the voting method to be used for the last three proposals, because a quorum was no longer present to vote. The Faculty Senate Chair decided to initiate the two-tier electronic voting process for the three remaining proposals.

- 3. Proposal for Revisions to the BS in Kinesiology
- 4. Proposed Minor in Professional Writing
- F. Committee on Handbook of Operating Procedures Dr. Mel Laracey Dr. Laracey mentioned the proposed revisions to HOP 4.04, 2.09, 2.29 and reported that the committee did not receive feedback from senators and did not identify any issues with the revisions.
