UNIVERSITY CURRICULUM COMMITTEE REPORT – FEBRUARY 21, 2013

Members of the University Curriculum Committee (UCC) were asked to consider a proposal for from the Department of Public Administration (DPA) in the College of Public Policy: Minor in Public Administration.

Minor in Public Administration

Currently, the DPA offers a Bachelor of Public Administration Degree. The Department of Political Science and Geography (DPSG) offers a Minor in Public Administration. If the minor offered by the DPA is approved, the minor offered by the DPSG will be phased out over a period of time in order to give each student who has already declared this minor an opportunity to complete it. The DPA is asking that the minor be implemented for the 2014–2015 catalog.

The new proposal indicates that the minor is designed to provide undergraduate students with foundational knowledge of the public sector, and it is open to students in any discipline. Exhibit A provides the degree requirements (18 total semester credit hours) including nine required and nine elective semester credit hours. Exhibit B provides the degree requirements for the minor offered by DPSG for comparison purposes.

After a thorough review of the proposal, the committee recommended approval.

Be it resolved that the proposal for a minor in Public Administration be approved.

Exhibit A

Minor in Public Administration

The minor in public administration is open to students in any discipline. The minor in public administration provides undergraduate students with foundational knowledge of the public sector. This includes fundamentals of public leadership and management, the meaning of public service in a diverse society, ethical decision-making, and the practice of policy formation and implementation. All students seeking the Minor in Public Administration must complete 18 semester credit hours.

A. All students seeking the Minor in Public Administration must complete the following 9 semester credit hours:

PAD 1113 Public Administration in American Society

(3-0) 3 hours credit.

This functions as the general introductory course in public administration. The management of government bureaucracies including organization, human resources, career systems, and financing is discussed. There is a discussion of the role of bureaucracies in modern society in the formulation and implementation of public policy.

PAD 3013 Introduction to Public Policy

(3-0) 3 hours credit.

The course introduces students to the different aspects of public policy in the U.S. political context. Topics may include agenda setting, policy formulation, implementation, analysis, and evaluation.

PAD 3023 Introduction to Urban Management and Policy

(3-0) 3 hours credit.

This course will introduce students to the basic concepts of the management of urban municipalities. Topics to be covered may include leadership in urban settings; organizational structure and change; delivery of urban services, particularly in a diverse urban environment. The course will also cover the process of policy formation, implementation, and evaluation in the municipal setting.

B. Students must also take 9 semester credit hours of which at least 6 credit hours must include the PAD or NPO designated classes, listed below.
