SUMMARY MINUTES OF THE FACULTY SENATE MEETING of May 1, 2014

The regular monthly meeting of the Faculty Senate for the 2013-2014 academic year was held May 1, 2014, at 3:30 p.m. in the Assembly Room (JPL 4.04.22) with Dr. Rebekah Smith, Chair of the Faculty Senate, presiding.

I. Call to order and taking of attendance

II. Approval of the April 10, 2014 meeting minutes

The minutes were approved.

- III. Reports
 - Provost's Report John Frederick
 Dr. Frederick said that there has been an initial presentation of the tuition and fee proposal, but said there have been no decisions made from that meeting yet. He

said that a System-wide proposal will be sent to the Regents, but it will take a few weeks to hear back on the proposal's status.

He addressed a question regarding the status of the search for a new Chancellor. He said he has no information regarding the search and details will likely not be shared until an official decision is made and the new Chancellor is announced.

Dr. Frederick explained that the faculty search process and corresponding manual are continuously being reviewed and improved upon. He said that Dr. Zapata and Dr. Smith are also being contacted for input. Dr. Frederick assured the senate that the process is continuously reviewed and improvements are made by consulting the appropriate parties. The senate expressed their concern that faculty search committees are no longer able to provide the department chair with a written recommendation letter. Dr. Frederick said that the department chairs are also not able to provide a written letter to the Deans. He said that the Deans are expected to be rigorous and thorough in their reviews and they should ensure quality and diversity in the pool of candidates. He stressed the importance of involving the entire department in the search process, and reminded the senate that this level of peer participation differentiates universities from corporations, where there is not always guaranteed peer participation. Although written letters are no longer requested, the reviews of the faculty search committees, department chairs, and Deans are still just as vital to the search process.

Dr. Frederick said that there have been some questions regarding whether or not office hours are required, and if so, how many? He said that fixed office hours may not necessarily be the most useful method for students to get help from faculty outside of the classroom. He said that there should be some expectation set for office hours, but encouraged faculty to work together to formulate a statement or method to covey this expectation.

He reminded the senate that commencement is one week from this weekend at the Alamodome. He expects that the ceremonies will be shorter and encouraged faculty to attend.

He thanked Rebekah Smith for her leadership as chair of the Faculty Senate and acknowledged her hard work and dedicated contributions to the senate.

B. Chair of the Faculty Senate – Rebekah Smith

GRIP and Chair's Council

Dr. Smith said that the GRIP meeting had been pushed to June. The next Department Chair's Council meeting is May 14.

Faculty Mentoring

She discussed the results of the faculty mentoring survey, noting that faculty were split in their responses about whether departments should be required to participate, but almost uniformly opposed to requiring that tenure track faculty participate. Due to the split responses, the recommendation is for more discussion on whether or not departments will be required to participate. If the policy is made mandatory, participation would be linked to evaluation for promotion. Therefore, any recommendation to make mandatory should be brought to the senate for vote. *HOP policies*

Dr. Smith said that feedback on HOP 8.06 Special Use Facilities should be provided to her by June 4. She said that feedback on HOP 2.34 Faculty Grievance

Procedures was due yesterday and the senate will vote on the HOP committee's recommendation at the September senate meeting. *SYSFAC*

Dr. Smith said that she and Dr. Daas attended the SYSFAC meeting April 17-18. She said that the US System taskforce for revisions of Intellectual Property Regents' Rules includes no faculty other than those with administrative positions. SYSFAC passed a resolution on the importance of faculty involvement. In addition, a model policy regarding department chairs was approved by SYSFAC. Other resolutions included a statement on Conflict of Interest, specifically the overreach of UTS 175; a resolution on faculty development centers; an expression of support for faculty diversity; a resolution that faculty should not be required to teach uncompensated overload, and should not treat teaching of organized courses as service; and a resolution thanking Executive Vice-Chancellor Pedro Reyes and Chancellor Cigarroa for their service. Dr. Smith said that the April 24 THECB meeting included consideration of a report on whether or not to allow community colleges to offer bachelorette degrees and another report on consider formula funding. Reports are currently available online for public comment.

<u>PeopleSoft</u>

Dr. Smith reminded the senate that faculty must elect a 9-month distribution in PeopleSoft if they have or might have external funding for salary during the academic year (this applies to adjuncts, NTTS, tenure-track, tenured, and research faculty). An NTT teaching one semester is considered "pay over contract". If someone is already on a 9/12 month spread and do not wish to change (with no external grant-funded salary during the academic year), no action is needed. If a faculty member is on a 9/12 spread, but expects to have external salary during the academic year, the distribution must be changed to 9/9. Also, if a faculty member does not have a form currently on file, and does not submit a form, then their salary will be paid over 9 months. Dr. Smith said that PeopleSoft go-live is today and encouraged the faculty to be patient with their colleagues and staff members who are learning this new system.

Faculty Senate Membership

Dr. Smith reminded the senators that their current senate term (as well as committee memberships) both officially end on August 31st. She thanked the senators for their support and efforts throughout the year and encouraged everyone to attend the Faculty Center Mixer after the meeting. She also noted the excellent work of Sarah Leach in facilitating the business conducted by the Senate.

IV. Election of Officers and Members of Standing Committees

The senate voted to unanimously approve the slate of candidates for all standing committees and panels as presented by the Nominating, Elections, and Procedures committee. Paper ballots were used for the Executive Committee elections, as multiple nominees were presented for selection.

Results of the Election can be found in Appendix A and Appendix B.

V. Reports, con't.

- C. NEP Committee Rebekah Smith (for Karen Daas) Dr. Smith said that the NEP committee is considering a bylaws change to allow a representative from the Department Chairs' Council serve as an ex-officio member of the senate's HOP committee. The representative would be recommended by the Chairs' Council and approved by the senate. Other elected members of the committee can also be chairs, but this would assure at least one chair to facilitate communication and input between the groups. The NEP committee will ask the senate to vote on this change at the September meeting.
- D. Consent Calendar Elaine Sanders Dr. Sanders discussed the Certificate in Language Acquisition and Bilingual Psychoeducational Assessment as part of the department of Educational Psychology's strategy to meet both the growing needs of UTSA and the community. The Graduate Council has already approved this certificate. The Faculty Senate consented to the Certificate in Language Acquisition and Bilingual Psychoeducational Assessment proposal.
- VI. Unfinished Business

There was no unfinished business.

- VII. New Business
 - VPR Strategic Plan Mauli Agrawal, Vice President for Research

Dr. Agrawal said that UTSA's strategic plan is still in the development process. He said that research and sponsored project expenditures have been steadily increasing (with a slight decline in the past 2-3 years). In 2013, UTSA was at approximately \$51M. He said that achieving \$100M in research expenditures is one of criteria to be considered a Tier One institution (as specified by the coordinating board). He stressed the importance of investing in current as well as new faculty members in order to increase funded research. Dr. Agrawal said that potential clusters have been formed across various disciplines. These clusters include both areas already showing funding success, as well as emerging disciplines. Each of the colleges is represented in both of these groups. He explained that a transition or disruption in our culture must occur for UTSA to achieve its' Tier One goal. It has been recommended to the President to review UTSA's resources and possibly reallocate them to place an emphasis on faculty growth and achievement.
