# SUMMARY MINUTES OF THE FACULTY SENATE MEETING of April 21, 2016

The regular monthly meeting of the Faculty Senate for the 2015-2016 academic year was held April 21, 2016, at 3:30 p.m. in the Assembly Room (JPL 2.04.22) with Dr. Karen Daas, Chair of the Faculty Senate, presiding.

#### I. Call to order and taking of attendance

## II. Consent Calendar

### III. Reports

#### A. Chair's Report – Karen Daas

Dr. Daas said that HOP 5.09 Class Attendance is currently under revision and a new version will likely be distributed next month, or in the fall. HOP 4.20 Authorized Leave is also currently under revision. HOP 9.48 Carrying of Concealed Handguns on Campus is a new policy that will be reviewed at the Regent's next meeting in spring/summer. The policy was drafted by Legal Affairs and will be reviewed/approved by the Regents. Although the policy is not currently under stakeholder review, it can be reviewed in the fall to address any concerns/proposed changes. Dr. Daas reminded the senate that committee elections will be held at the senate's May 5<sup>th</sup> meeting, and that new senators are welcome to attend. The annual Faculty Senate Mixer will immediately follow.

## B. Secretary of the General Faculty – Jill Hernandez

Dr. Hernandez said that SYSFAC's Academic Affairs committee is continuing work on dual credit, with site visits temporarily on hold. She said that a resolution was drafted stating that DFW rates shouldn't be tied to performance evaluations. The resolution has been sent to the Chancellor and Regents. The Academic Affairs committee plans to look at faculty-generated resolutions to this issue in the fall. The coordinating board's 60x30 initiative is a goal for 60% of Texans to have post-high school credentials (dual credit, degrees, certificates, etc.) by 2030. This is another long-term project that the Academic Affairs committee will be looking at.

Dr. Hernandez said that a whitepaper on shared governance is being developed based on an institutional survey conducted last fall. She said that the Teacher's Retirement System currently has a \$1.6 billion shortfall that will be looked at in greater depth in the fall. Dr. Hernandez confirmed that she had been appointed to the faculty workload taskforce along with Dean Gelo as UTSA's representatives.

She said that graduate student funding was discussed during the UT System visit to UTSA. The CONACYT initiative, a partnership between UTSA, the Regents, and Mexican institutions which will bring research money to Ph.D.s, was also discussed. Dr. Hernandez said the next SYSFAC executive meeting will be held May 16<sup>th</sup>.

- C. NEP Committee Jim Dykes (for Emily Bonner)
  - Dr. Dykes announced Dr. Emily Bonner as the sole nominee for 2016-2018 Faculty Senate Chair. There were no other nominations from the floor, so Dr. Bonner was elected by acclamation.
  - Dr. Dykes announced Dr. Jill Hernandez as the sole nominee for 2016-2018 Secretary of the General Faculty. There were no other nominations from the floor, so Dr. Hernandez was elected by acclamation.
- D. Campus Carry special committee Gregory Hazleton

Dr. Hazleton said that students and faculty had been surveyed regarding their thoughts on Campus Carry, and the results were forwarded to the President's office. Dr. Hazleton requested that the committee stay in place next year to further assess the impact of Campus Carry. At the committee elections next month, the senate will vote on whether or not to keep this special committee in place.
