SUMMARY MINUTES OF THE FACULTY SENATE MEETING of May 3, 2018

The regular monthly meeting of the Faculty Senate for the 2017-2018 academic year was held May 3, 2018, at 3:30 p.m. in the Assembly Room (JPL 4.04.22) with Dr. Emily Bonner, Chair of the Faculty Senate, presiding.

I. Call to order and taking of attendance

II. Consent Calendar

- Approval of minutes April 12, 2018 The minutes were approved.
- Election of Standing Committee Members for 2018-2019 The committee ballots were approved. Results can be found in Appendix A.

III. Reports

A. Chair Report – Emily Bonner

Dr. Bonner remind the senate that terms expire August 31st for current members (those with expiring terms) and terms for new members begin September 1st. She said that the executive committee is planning a senate retreat sometime the week of August 13th to discuss goals for the upcoming year. Outgoing and incoming senators are all welcome to attend.

She said that updates were provided at the most recent SYSFAC meeting regarding the dual credit study, paid family leave policy, and the subcommittee that is finalizing a

report on NTT faculty and freedom of speech. The third student success summit is also in the planning stages.

Dr. Bonner said that she has been working with SGA leadership and is proposing a joint statement between Faculty Senate and the Student Government Association to create a taskforce that will investigate possible solutions to plus/minus inconsistencies. If approved, the group (composed of faculty and students) will present their findings by December 2018 to both bodies. *The senate voted to approve the joint statement by a vote of: 32 approve, 2 do not approve, and 1 abstention.*

Dr. Bonner said that discussions are continuing regarding the budget, and the plan is to run both the current and proposed budget models next year. VP search committees will be formed soon and there may be an opportunity for volunteers to serve on these committees. Dr. Bonner thanked the senate for their hard work this year.

- B. Provost's Report Jesse Zapata (for Mauli Agrawal) No report.
- C. NEP Committee Chad Mahood

Dr. Mahood announced that Dr. Joshua Thurow has had to step down as Secretary of the General Faculty and a replacement is needed. Only one nomination was received and *Dr. Chris Packham was elected by acclamation to finish Dr. Thurow's term as Secretary of the General Faculty for 2018-2020.*

The following nominations for senate executive committee positions were received by the April 30 deadline and all were elected by acclamation:

- Faculty Senate Vice Chair: Dr. Chad Mahood
- Faculty Senate Parliamentarian: Dr. Raydel Tullous
- Faculty Senate Secretary: Dr. Crystal Kalinec-Craig

The senate voted on the proposed bylaws changes discussed at the last meeting. The major changes include:

- 1. Shift Vice Chair position to Chair Elect in alternating years. Election would take place at May meeting one year before term takes effect.
- 2. Add one permanent ex-officio (voting) non tenure-track faculty member to the senate executive committee (elected or selected from ADTS).
- 3. Add provision so that anyone who is (1) on FAC executive committee, and (2) currently not on UTSA's senate, may serve ex-officio on UTSA senate and EC. A question was asked regarding the eligibility of NTTs (other than senior lecturers) to serve on the senate. Another question was asked about the eligibility of faculty members in administrative positions such as assistant department chairs. Dr. Mahood asked that these comments be sent to him to review at a later date. *The senate voted to approve the proposed bylaws changes by a vote of: 31 approve, 0 do not approve, and 5 abstentions.*
- D. Curriculum Committee Sakiko Oyama

Dr. Oyama said that the Curriculum Committee reviewed the proposed 2018-2020 undergraduate catalog. The committee checked to ensure all proposals passed through the senate last year had been incorporated into the catalog. Only one program was left out of the catalog (BA in Cyber Security) due to funding issues. *The senate voted to unanimously approve the committee's report by a vote of: 32 approve, 0 do not approve, and 0 abstentions.*

IV. Unfinished Business

• UT Lands climate action resolution

• Les Shephard, Professor of Civil Engineering and Faculty Senator The Faculty Senate agreed with the spirit of UT Austin's resolution reviewed at the last senate meeting, but wanted to further refine it. Dr. Shephard said that he worked on drafting UTSA's resolution with Emily Bonner, Melvin Laracey, and Hongjie Xie after clarifying some information with the university lands office. Two substantive changes were proposed to UTSA's resolution:

- 1. "...with a goal to reduce GHG emissions on University Lands by 50% or more within 5 years." Added the statement "or more".
- 2. Changed the title from "Resolution to Reduce Methane Gas Emissions from Hydraulic Fracturing Operations on University Lands (UL)" to "Resolution to Reduce Green House Gas Emissions from Hydraulic Fracturing Operations on University Lands (UL)" to allow for more inclusivity of various gas emissions.

The senate voted to unanimously approve the resolution by a vote of: 37 approve, 0 do not approve, and 0 abstentions.

V. New Business

• Sexual harassment subcommittee resolution

• John Nix, Professor of Music and Faculty Senator Professor Nix said that his subcommittee (including himself, Crystal Kalinec-Craig, Richard Harris, and Jennifer Alexander) put together a resolution to stress the importance of this issue and request ongoing dialogue and an improved reporting mechanism. *The senate voted to unanimously approve the resolution by a vote of: 36 approve, 0 do not approve, and 0 abstentions.*

- Updates on university initiatives
 - Can Saygin, Interim Senior Vice Provost for Institutional Effectiveness & Strategic Initiatives

Dr. Saygin discussed the President's ongoing initiatives, including the new downtown initiative. He said that the approach is to prioritize initiatives and ideas related to "level 1" goals. These are high impact/low effort goals, which will get things moving quickly with a larger payoff. Other goals within the plan include high impact/high effort (level 2), low impact/high effort (level 3), and low impact/low effort (level 4). Each idea/goal has been grouped into one or more of these levels. Dr. Saygin stressed the importance of communication and involvement related to these ideas. He encouraged the senate to pick 2-3 issues they would like to see improved or solved, and said that once the new Provost is onboard these topics can be further expanded.
