Summary

• <u>Function</u>: To promote optimal wellness enabling students to make informed decisions about health related concerns and empowering students to be

self-directed and well informed consumer of health care services.

• Scope: Utilize the nursing process to deliver holistic, student-focused care. Care is

Duties

1. Typical:

- 1. Provides health care services to eligible students within standard RN scope of practice defined by Texas state law. The nurse will utilize Student Health Service's (SHS) policies/procedures and standing orders. Maintain currency of licensure as required by the Texas Board of Nursing.
- 2. Provide nurse triage to students. The nurse will create an atmosphere where the student feels welcome, supported and engaged in their health care decisions. Deliver appropriate care to include emergency care, first aid, self-care advice, and schedule an appointment with Student Health Service provider and/or referral to a community resource as appropriate.
- 3. Administer medications/vaccinations/TB screening, phlebotomy, lab and other procedures in accordance with established medical practices/pharmaceutical guidelines/clinical procedures and protocols.
- 4. Manage the Student Health Services e-mail and medical hold removal by reviewing documentation provided by students. Participate in new student orientations to review immunization and TB documentation.
- 5. Maintain accurate documentation and confidential medical records following HIPAA/FERPA standards. Document nursing assessment and treatment in the electronic health record.
- 6. Maintain AAAHC Standards of care.

- 7. Assist SHS medical provider during the examination and treatment of patients.
- 8. Maintains drugs, medical supplies, and ensure their appropriate storage in locked cabinets and refrigerators: maintain inventory, review expiration dates and appropriately dispose of expired stock in accordance with federal and local regulations. Perform and record monthly quality assurance testing on medical devices. Order and maintain inventory on all other medical supplies.
- 9. Process laboratory specimens and results per SHS policy. Performs quality control procedures on laboratory testing equipment.
- Actively participate in quality assurance activities, nursing meetings, departmental meeting, and nursing peer review.
- 11. May have specially assigned areas of responsibility and other duties as assigned by the Nursing Supervisor and the Nursing Director.
