- 2. Scope document, appropriate to the project, is completed prior to programming
- 3. Writes program specification
- 4. Convert designs and specification into functional application
- 5. Has a working knowledge of data management, data modeling, experience with PL/SQL or MSSQL, and general reporting methodologies
- 6. Prepares and executes integrated test plans using efficient testing methods. Involves users in the testing, consults with users to prototype, refine, test and debug programs to meet needs; installs and test programs at clients sites; monitors performance of programs after implementation
- 7. Writes and maintains documentation of changes to computer programs and specification; modifies and maintains software programs written by other; is familiar with OOP solutions develops and maintains plans outlining steps and time tables for developing programs
- 8. Design and code layout for users interfaces, reports, and interfaces with other systems
- 9. Reviews user and technical documentation written by others to confirm consistency by programs operations
- 10. Provide technical assistance by responding to inquiries regarding errors, problems, or questions with programs
