Duties

• Typical:

- 1. Installs, operates, adjusts and maintains audio-visual equipment including projectors, monitors, public address systems, computers, cameras, recorders and others in classrooms, labs, exhibits and conference rooms.
- 2. Oversee arrangement of laboratories and classrooms for use and operation of equipment used in instruction. Maintains, monitors, updates and secures equipment.
- 3. Perform repairs and maintenance on equipment.
- 4. Coordinate, plan and provide audio-visual set-up and support for special events and projects.
- 5. Train faculty, staff, students and visitors in proper use and care of audio-visual equipment and technology.
- 6. Oversee audio-visual transmission for distance learning. Prepares equipment and schedules transmissions.
- 7. Perform additional duties as assigned.
