#### Melissa Vito

Academic Innovations office is currently working on collecting student feedback; once the office can put together the feedback responses, the office will pull it together and send out. More colleges and campus offices currently sending out surveys. What the Academic Innovations office is hearing from students: similar to faculty; jarring to have to move and transition quickly, internet and technology reliability. ZOOM bombing and crash in blackboard. Feelings about courses are mixed. Some faculty are holding to the same standard in the classroom and some faculty are giving up in the classroom. ## A. Curriculum Committee -

**Raj**: Undergraduate Curriculum catalog changes the senate reviewed and approved. All changes are in the catalog have been approved by senate except for 4. Anything that was approved by the faculty senate but is not in the catalog, happened after the deadline in October. **The Faculty Senate voted as follows: Approvals: 37,** 

Extensions: 0, Abstain: 1

**Si Millican & Heather Shipley:** answering questions about the course catalog. Electronic Vote can be made. Si has a core curriculum study; general education curriculum is core and makes up about 34% of UTSA degrees. Proposing a self-study on the core curriculum with a SWOT analysis at UTSA that has not been done before. Colleagues across the entire campus would have the opportunity to get involved. Timeline: committee starts in Fall 2020 collecting data and analyze the data in Spring 2021.

**Nathan Richardson** – Chair Council Rep: budget planning. (*shared document to faculty senate*) The 9% budget cut in depts. Are actually more than 9%; what these cuts are actually doing to the departments. Faculty Senate will receive a final version of memo and then have a vote of support.
