

FACULTY SENATE – OCTOBER 11, 2012 MEETING
UNIVERSITY CURRICULUM COMMITTEE
REPORT #1

The University Curriculum Committee (UCC) previously reviewed and presented recommendations for 117 course proposals for the UTSA Core Curriculum, and these were approved by the Faculty Senate at the September 13, 2012, meeting.

Twenty other course proposals had been denied by the Core Curriculum Committee and were under revision. The UCC received the revised proposals, and at a meeting of the UCC on September 28, 2012, the members reviewed each proposal and made recommendations. Appendix A provides the UCC's recommendations for each of the twenty proposals.

Be it resolved that the recommendations for the twenty course proposals be approved as noted on Appendix A.
